 - o Nominations will remain open until one (1) week prior to UG 21
- Jonathan Stewart, MBIX
 - o Hoping to learn from MICE and how we're operating
 - Main tech for MBIX
 - Would like to look at working with MICE to make more available via MBIX
 - Answered a number of questions and there was a lot of general discussion regarding IX's and their purpose
- Fee Structure
 - Cannot hold funds until we have filed for our non-profit status

- Need to establish a baseline, or range of scenarios, for how much money we need to operate and sustain the exchange; we'll hold a meeting to update the projections/scenarios within the next 30 days
- The discussion about fee structure and distribution of fees is tabled to UG 21
- Also need to work with Cologix at getting a 10 year+ agreement for collocation services
 - Jay Hanke will follow up on this
- Also need to discuss revenue building blocks (options), how do we raise revenue to fund projects; this
 will be a follow-up to the cost discussion
- Equipment update for the MICE core
 - o A lot of equipment and pricing changes are driving costs down
 - O This may drive some changes to how/what we're going to use in the IX core

Open Discussion / Announcements

- Elections at UG 21
 - o Nominations are open, send your nominations to the board or the discuss list
- Remote Switches
 - o Richard is adding the formal application process to the website
 - Discussed DataBank's application
 - o ipHouse has applied to be a remote switch and is awaiting equipment
 - Edgeconnex has fiber to the facility now, has not yet turned up connectivity with MICE
- Akamai Status Update
 - SSL and Freeflow capability up in regions now; will be adding more hardware in the coming weeks;
 peering sessions are up that they know about.
 - They are having problems with their peering email if they have not yet responded; in the meantime, if you have not received a response to your peering request, please send a new request to peering@akamai.net and cc owen@akamai.net to get the process rolling again.
- University of Wisconsin is unable to be a member of this organization due to Wisconsin law. The bylaws do not explicitly mandate membership. We list "participants" on the website currently. We will need to accommodate this in any legal documents in the future.
 - Richard Laager suggested that the board adopt a policy of explicitly approving members at each board meeting. This removes the ad-hoc methodology and formalizes the process of ensuring members meet membership requirements. The board will adopt this going forward for new members.
